## Hard Sayings In The Bible

I read this verse from Morning Prayer this morning and thought, "How would I be able to do that?". I almost immediately recognized two things about myself. The first one is how legalistic I am. I am expecting myself to be able to what God asks of us in the Bible on my own power. Expecting to perform the rhythms of the Christian life with no outside help, especially from God, is a very inflated view of myself, and a very rules oriented, or legalistic, way of living.

### The Second Thing I Saw About Myself

I really cannot do what God asks me to do on my own power. That realization is at the core of living a Christian life. I need God to follow God. I need Jesus to be like Jesus. I need the Holy Spirit to respond to the Holy Spirit. It is impossible to become who I am created to be by myself. I need the Creator to do that. I am not being sued by another Christian. The verse above is only one verse taken out of context. But if I were to find myself in a serious legal situation I know that I could not live up to the humility and sacrifice Paul describes on my own. I would need to rely on the grace of God.

#### **Overflow**

Anything we do as a Christian that will bear fruit for the kingdom of God will come from the overflow of my engagement with Jesus. Worshiping with others, seeking after Jesus and His Kingdom, will fill me with the Spirit of God. The fruit that comes from my life and work will be from the overflow of the Spirit of God through my life. That works for anyone. What is God asking of you today that requires His presence to accomplish?
